PRIVACY STATEMENT - VAN CAEM KLERKS GROUP

1. INTRODUCTION

- 1.1 This Privacy Statement is based on the European General Data Protection Regulation (which replaces the Data Protection Directive 95/46/EC) ("the GDPR"), the Dutch "Algemene Verordening Gegevensbescherming" ("the AVG") and all associated legislation as issued by the legislation authorities.
- 1.2 This Privacy Statement sets out the basis on which any personal data VCKG Holding B.V. (registered at the Dutch Trade Register under no. 854527953), VCF Holding B.V. (registered at the Dutch Trade Register under no. 68443633), Van Caem Oriental Holding Ltd. (registered at the Trade Register in Cyprus under no. HE 378286), VCW B.V. (registered at the Dutch Trade Register under no. 64796833), VCLX N.V. (registered at the Curacao Commercial Register under no. 13824) and any of their direct and indirect subsidiaries (collectively, "the Group", "us", "we" or "our") processes from a client and/or prospective client, business partners and/or other contracting parties (hereinafter collectively referred to as "Client"), or that the Client provides to the Group, will be disclosed, used and/or processed by the Group.

2. PERSONAL DATA

Wordpress and Wordfence ensure that the Website is working properly. With Google Analytics we can monitor how many persons have visited our Website.

4. USE OF PERSONAL DATA

- 4.1 Processing your personal data
